There is significant information in this study. However, it needs to be presented properly with the arrangement of sentences and the suitability of the paragraphs equipped with the latest and reputable references

**Relationship to Literature: Does the paper demonstrate an adequate understanding of the relevant literature in the field and cite an appropriate range of literature sources? Is any significant work ignored?**

Authors need to work hard to present holistically so that the research results can be understood properly. Emphasis on references and citation methods should be the concern of the author.

**Methodology: Is the paper's argument built on an appropriate base of theory, concepts, or other ideas? Has the research or equivalent intellectual work on which the paper is based been well designed? Are the methods employed appropriate?**

The theoretical basis and methods used are appropriate. But it needs to be repaired and equipped.

The results of the analysis have been carried out well, but some conclusions have not been presented comprehensively.

The author has not presented the implications of the research results, as well as recommendations for further research.
